Vide reference (ii) above, RCIL has informed that new CUG tender has been finalised and has requested Board's approval for its implementation. This is being considered in Board.

In the meantime, in reference to the proposal received vide RCIL's email dated 31-03-2022, approval of Railway Board is hereby communicated for the extension of existing CUG contract with the incumbent telecom service provider viz. M/s Reliance Jio Infocomm Ltd. for a period of one more month beyond 31.03.2022 i.e. from 01.04.2022 up to 30.04.2022. As the new contract is proposed to be awarded to M/s Reliance Jio Infocomm, who is also executing the current contract, this extension is to be done with the latest rates as informed vide letter under reference (ii) above.
