The Joint Working Order (JWO) for the enlarged CUG scheme of Indian Railways is presently under finalisation. The enlarged CUG scheme will also have provision for M2M SIMs to be utilized for HHT devices as provided for in Board's letter No.2022/Tele/11(2)/4(3398809) dated 15.07.2022 (Telecom Circular No.06/2022).

2. In order to enable functionality of all M2M SIMs(including the ones being provisioned in Joint Working Order (JWO) for the enlarged CUG scheme under finalisation) to be utilized for HHT devices, Zonal Railways are advised to have the M2M SIMs configured by whitelisting the IP addresses/URLs as provided vide CRIS's letter dated 24.02.2023 (enclosed).
